Shepherd's Center helps individuals and families avoid homelessness, achieve stability, and move toward self-sustainability by offering housing and employment support that includes one-on-one guidance, referrals to community resources, and short term financial assistance for rent, utilities, transportation, and other work-related needs. Our volunteers contributed approximately 2,500 hours to provide over 500 client sessions in the past fiscal year.

4b (Code:) (Expenses \$ 141,704. including grants of \$ 21,022.) (Revenue \$)

Holy Ground provides opportunities for men and women to exit homelessness, grow in faith, connect to a supportive community, and take steps towards a stable, productive life. Our programs include mentorship, fellowship, recovery groups, Bible study, community service, and enrichment activities. The Holy Ground Garden allows people from various backgrounds, season of life, and circumstances to work together in the care of a beautiful, diverse garden that glorifies God's creation. Program participants and volunteers work side-by-side to produce fresh, healthy vegetables and herbs used to prepare meals and to share with other community members. Holy Ground volunteers contributed 2,300 hours to serve nearly 1,500 participants.

Operation ID helps vulnerable community members rebuild their lives by assisting them in obtaining an official identification for the purpose of employment, housing, or other support services. We work in collaboration with over 60 community agencies and help clients gather needed documentation, pay required fees, and complete applications necessary to obtain a Texas identification card. This 30+ year old, volunteer run program is the primary identification assistance provider in Houston. This fiscal year, volunteers contributed 7,000 volunteer hours and assisted nearly 5,000 clients.
