Main Street Ministries Houston is a Christ-centered, volunteer empowered organization focused on effective solutions for those of our community in crisis, providing them the opportunity to change their lives for good.

The Shepherd's Center assists individuals and families that are homeless, or at risk of becoming homeless, secure stable housing and work. We provide individualized guidance, referrals to other community resources, as well as financial assistance including utility, rent, and transportation as our clients take steps towards self-sufficiency. Our volunteers contributed approximately 3,800 hours to provide nearly 2,000 client sessions in the past fiscal year.

4b (Code:) (Expenses \$ 134,767. including grants of \$ 127,349.) (Revenue \$ 72,544.)

Operation ID is a 30 year old, all-volunteer organization with a mission to assist families in crisis, victims of natural disasters, ex-offenders, and the indigent by providing guidance and financial assistance to those needing to obtain legal identification documents. It is one of the largest, if not the only, all-volunteer group providing this identification service in Houston. Operation ID's volunteers contributed 7,200 volunteer hours and assisted over 6,500 clients.

Holy Ground is a community of hope and place of refuge for homeless men and women where change is encouraged through small group studies, fellowship, worship activities and personal discipleship. Holistic growth is promoted through a variety of classes aimed at inspiring a healthy relationship with God, self, others and the rest of creation. The Holy Ground Garden provides opportunities for those in transition to develop work habits and relationships designed to empower them as they seek employment. In the past year, volunteers contributed nearly 6,000 hours of service to serve around 7,000 attendees.
